THE SMALL PRINT

Medway Yacht Club hereafter referred to as 'The Club' and yourself as 'the Hirer'.

- 1. External hirers of The Club must be aware that use of the clubhouse/bar venue is not exclusive. Members are permitted to use the Dragon bar when it is open.
- 2. Minimum number for functions is **20** the maximum number for a sit-down meal is 100, standing 120. Should numbers not reach the minimum required then a charge of £25 per person will need to be paid to make up to the 25 minimum.
- 3. The Club reserves the right to cancel and refund a booking. If in the unlikely event The Club needs to cancel a function, The Club will always try to ensure plenty of notice is given.
- 4. Please choose a maximum of two choices per course. A vegetarian option may be included too. We can cater for those with allergies, intolerances, or dietary requirements.
- 5. Final payment, choices & numbers must be with us no later than 14 days prior to the event date (it is very important to ensure we receive information about any allergies or intolerances by this time).
- 6. No refunds will be given for cancellations with less than 14 days' notice.
- 7. All Hire costs are non-refundable at point of payment. Hire costs and any reasonable administration costs will be kept should there be a cancellation outside of the 14-day notice period
- 8. Functions only External Room Hire fees are due at the time of booking. If in certain circumstances a hire fee is not due, (see below) then a £100 deposit must be paid to confirm the booking.
- 9. If the hirer or host is a member and paying in full, they will receive a 10% discount off the food prices listed in this pack. To obtain the discount, 50% of the guests must be members.
- 10. If the hirer or host is a member and paying in full, the Hirer may not need to pay the hire charge, to obtain this discount, 50% of the guests must be members.
- 11. We will provide temporary membership to all guests for a specific event & time in accordance with club rules.
- 12. Class events are exempt from the hire fee and receive 10% off the Main 'Function Menu' only.
- 13. All prices inclusive of VAT.
- 14. The Hirer are welcome to bring a celebration cake but no other food or drink to be brought onto the premises without the express permission of the General Manager.
- 15. Linen table clothes are included free of charge.
- 16. If hiring a DJ or band, we are required to obtain a copy of their liability certificate.
- 17. Our kitchen will always contain a trace element of nuts and other allergens.
- 18. Functions will finish at Midnight on a Friday and Saturday. All other nights finish at 11pm.

- The Hirer will during the period of using be responsible for supervision of the use of the premises
 the fabric and contents, their care, safety from loss or damage however slight or change of any
 sort, and the behaviour of all persons from their group using the premises, whatever their
 capacity, including proper supervision of car parking in all areas designated by Medway Yacht Club,
 to avoid obstruction to MYC members' boats, dinghies and cars.
- 2. The Hirer shall not sub-hire or use the premises or allow the premises to be used for any unlawful purpose or in any unlawful way nor do anything or bring onto the premises anything which may be injurious to the interests of Medway Yacht Club or endanger the same or any insurance policies in respect thereof nor allow the consumption of alcoholic liquor thereon not previously purchased from the Medway Yacht Club bar.
- 3. Medway Yacht Club shall not be liable for any loss or damage to the property of the Hirer or those attending the event or those providing goods and/or equipment for the event. Medway Yacht Club shall have no liability under the Occupier's Liability Act. The Hirer is recommended to be fully insured against any loss or damage to property and any death or injury to persons.
- 4. The Club reserves the right to charge the hirer/event attendees for any damage to the club premises or property.
- 5. The Hirer shall comply with all conditions and regulations made in respect of the premises by Medway Yacht Club, the fire authority, local authority, the local Magistrate's court or otherwise, particularly in connection with any event which includes public dancing or music or other similar public entertainment or stage plays. Gambling is not permitted anywhere on the premises.
- 6. At the end of the use the Hirer shall be responsible for leaving the premises and surrounds, including toilets, in a clean and tidy condition, and any contents temporarily moved from their usual positions properly replaced. Medway Yacht Club shall be at liberty to make an additional charge to cover cleaning, redecoration, breakages, loss and damage.
- 7. In the event of the premises or any part thereof being or becoming unfit for the use for which it has been arranged, Medway Yacht Club shall not be liable to the Hirer for any loss or damage whatsoever.
- 8. Smoking is not permitted inside any of our venues.
- 9. The grass bank in front of the clubhouse is out of bounds. Dogs are not allowed anywhere at Medway Yacht Club (with the exception of guide dogs). Children must be properly & always supervised and must not be allowed to stray away from the premises into the boat parks, onto trolleys, boats, tractors, and other equipment and onto the pontoon or slip ways.
